APPROVING RESOLUTION NO. 233, S-2023 OF THE SANGGUNIANG BAYAN OF BASISTA, PANGASINAN, ENTITLED "APPROVING THE SUPPLEMENTAL INVESTMENT PROGRAM (SIP) NO. 2 FOR CY 2023 OF BASISTA, PANGASINAN"

WHEREAS, the Sangguniang Bayan of Basista, Pangasinan submitted its Resolution No. 233, S-2023 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said Resolution with the following findings:

1. The Municipal Development Council of Basista, Pangasinan prepared their Supplemental Investment Program (SIP) No. 2 for CY 2023. This was endorsed by the Council, through MDC Resolution No. 2, Series of 2023 dated July 13, 2023, to the Sangguniang Bayan for approval. This is in accordance to Sections 106, 109 and 114 of the Local Government Code of 1991;
2. Said Supplemental Annual Investment Program, which has a total investment requirement of ₱8,578,845.13, covers augmentation of funds for Personal Services (PS), Maintenance and Other Operating Expenses (MOOE) and Capital Outlay (CO) of the municipal offices, and implementation of LDRRM projects of the LGU; and

3. Funding for the Supplemental AIP is embodied in the LGU's Supplemental Budget No. 2, FY 2023, which was enacted by their Sangguniang Bayan through Supplemental Appropriation Ordinance No. 2, Series of 2023 dated July 24, 2023.

WHEREAS, the Sangguniang Panlalawigan, after final evaluation, finds the subject resolution in order, however, compliance with all the existing laws, rules and regulations shall be the responsibility of the Municipal Government of Basista, Pangasinan;

WHEREFORE, in view of the foregoing, on motion of SP Members Philip Theodore E. Cruz and Haidee S. Pacheco and co-sponsored by SP Members Jerome Vic O. Espino, Jeanne Jinky C. Zaplan and Arthur C. Celeste, Jr., duly seconded, it was—
