### RESOLUTION NO. 874-2023

**DECLARING ORDINANCE NO. 221, S-2023 OF THE SANGGUNIANG BAYAN OF BASISTA, PANGASINAN, ENTITLED "AN ORDINANCE INSTITUTIONALIZING THE MUNICIPAL NUTRITION ACTION OFFICE AS AN ORGANIZATIONAL UNIT IN THE MUNICIPALITY OF BASISTA, PANGASINAN ENUMERATING ITS FUNCTIONS AND APPROPRIATING FUNDS FOR ITS ANNUAL OPERATION" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIAN TO ENACT**

**WHEREAS**, the Sangguniang Bayan of Basista, Pangasinan submitted its Ordinance No. 221, S-2023 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

**WHEREAS**, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Legal Officer and the Local Finance Committee of the province have conducted initial review and study on said municipal ordinance and found out that the same was enacted in accordance with Sections 16 & 17 (a) (b) (2) (iii) and (iv) of R. A. No. 7160 and Section 15, Article II (Principles) & Section 11, Article XIII (Health) of the 1987 Philippine Constitution;




