**APPROVING SB RESOLUTION NO. 258-2023 OF THE SANGGUNIAN BAYAN OF MANGATAREM, PANGASINAN, ENTITLED “APPROVING MUNICIPAL DEVELOPMENT COUNCIL EXECUTIVE COMMITTEE (MDC-EXECOM) RESOLUTION NO. 2, SERIES 2023 OF THE MUNICIPALITY OF MANGATAREM, PANGASINAN”**

**WHEREAS**, the Sangguniang Bayan of Mangatarem, Pangasinan submitted its SB Resolution No. 258-2023 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

**WHEREAS**, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said SB Resolution with the following findings:

1. The Municipal Development Council of Mangatarem, Pangasinan proposed for the reprogramming of the project, Confidential Intelligence Fund, under the Municipal Peace and Order Program and Municipal Anti-Drug Abuse Program, CY 2023. The Peace and Order Program and Municipal Anti-Drug Abuse Program are components of the Annual Investment Program, CY 2023 of the Municipality of Mangatarem. The proposed reprogramming was endorsed by the Council to the Sangguniang Bayan for approval through MDC Execom Resolution No. 02, Series of 2023, dated May 10, 2023;
2. The Sangguniang Bayan approved said reprogramming through Sangguniang Bayan Resolution No. 258-2023 dated July 12, 2023, as follows;




