## **RESOLUTION NO. 876-2023**

APPROVING RESOLUTION NO. 374, S-2023 OF THE SANGGUNIANG BAYAN OF BAYAMBANG, PANGASINAN, ENTITLED "APPROVING THE SUPPLEMENTAL ANNUAL **INVESTMENT PROGRAM NO. 1 DULY INDORSED BY THE MUNICIPAL DEVELOPMENT COUNCIL (MDC) EXECOM THRU RESOLUTION NO. 003, SERIES OF 2023 AMOUNTING TO THREE** SEVENTY-THREE THOUS FIVE MILLION SIX-HUNDRED HUNDRED PESOS (P3,673,500.00)"

WHEREAS, the Sangguniang Bayan of Bayambang, Pangasinan submitted its Resolution No. 374, Series of 2023 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No.7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said Resolution with the following findings:

- 1. The Municipal Development Council of Bayambang, Pangasinan prepared the Supplemental Annual Investment Program No. 1 for CY 2023. This was endorsed by the Council, through MDC-Execom Resolution No. 003, Series of 2023, dated July 25, 2023, to the Sangguniang Bayan for approval;
- The Supplemental AIP, which has a total investment requirement of P3,673,500.00, covers the augmentation of funds for Personal Services (PS) and Maintenance and Other Operating Expenses (MOOE) of some offices of the LGU; and

3. Funding support for the LGU's Supplemental AIP is embodied in their Supplemental Budget No. 01, CY 2023 which was enacted by their Sangguniang Bayan through Appropriation Ordinance No. 01, Series of 2023 dated August 22, 2023.

WHEREAS, the Sangguniang Panlalawigan, after final evaluation, finds the subject resolution in order, however, compliance with all the existing laws, rules and regulations shall be the responsibility of the Municipal Government of Bayambang, Pangasinan;

WHEREFORE, in view of the foregoing, on motion of SP Members Shiela Marie F. Baniqued and Vici M. Ventanilla and co-sponsored by SP Members Jerome Vic O. Espino, Jeanne Jinky C. Zaplan and Arthur C. Celeste, Jr., duly seconded, it was–
