RESOLUTION NO. 88-2023

**DECLARING THE SUPPLEMENTAL BUDGET NO. 6 FOR
CALENDAR YEAR 2022 OF SUAL, PANGASINAN INVOLVING A
TOTAL APPROPRIATION OF P13,622,336.00, OPERATIVE IN
ITS ENTIRETY**

WHEREAS, pursuant to Republic Act No. 7160, otherwise known as the Local Government Code of 1991, the Sangguniang Panlalawigan of Pangasinan as a legislative body of the Province is empowered to review ordinances authorizing annual or supplemental appropriations of component cities and municipalities in the manner prescribed by law;

WHEREAS, the Sangguniang Bayan of Sual, Pangasinan submitted its Supplemental Budget No. 6 for Calendar Year 2022 involving total appropriations of P13,622,336.00 which was enacted on December 12, 2022 through Appropriation Ordinance No. 07;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Local Finance Committee of the Province pursuant to Section 316 of the Local Government Code of 1991, have conducted review and study on said budget with the following findings:

1. That the funding source for the subject Supplemental Budget was determined in accordance with Section 321 of R.A. No. 7160 and Article 417 (a) of its IRR as amended by Administrative Order No. 47 dated April 12, 1993;

2. That all programs, projects and activities shall be in accordance with the approved Local Development Plan and the FY 2022 Annual/Supplemental Investment Program of the municipality formulated pursuant to DILG-NEDA-DBM-DOF Joint Memorandum Circular No. 1, Series of 2007 dated 08 March 2007;
3. That all procurements to be undertaken shall be subject to provisions of RA. No. 9184 (The Government Procurement Reform Act) and its revised Implementing Rules and Regulations;
4. That the reversion of savings from the Personal Services and Maintenance and Other Operating Expenses shall be in accordance with the provisions of Section 336 of R.A. 7160 (Use of Appropriated Funds and Savings);
5. That the grant of Performance-Based Bonus for Calendar Year 2021 (PBB) for all municipal officials and employees of the municipality shall be in accordance with the provisions of Inter-Agency Task Force on the Harmonization of National Government Performance Monitoring, Information and Reporting Systems Memorandum Circular No. 2021-1 dated June 3, 2021;
6. That the grant of Other Personnel Benefits - Collective Negotiation Agreement (CNA) Incentive for FY 2022 to municipal officials and employees shall be in accordance with the provisions of Budget Circular No. 2022-3 of the Department of Budget and Management dated October 19, 2022; and
7. That the grant of Other Personnel Benefits - Service Recognition Incentive (SRI) to regular and casual employees for Fiscal Year 2022 shall be subject to the provisions of Budget Circular No. 2022-04 dated December 20, 2022.

WHEREAS, the Sangguniang Panlalawigan after final evaluation, finds the same in order provided that the findings shall be complied with by the municipality;

WHEREFORE, in view of the foregoing, on motion of SP Members Napoleon C. Fontelera, Jr. and Apolonia DG. Bacay and co-sponsored by SP Members Jerome Vic O. Espino, Jeanne Jinky C. Zaplan and Arthur C. Celeste, Jr., duly seconded, it was –


