RESOLUTION NO. 886-2023

DECLARING ORDINANCE NO. 23-12 OF THE SANGGUNIANG PANLUNGSOD OF SAN CARLOS, PANGASINAN, ENTITLED "THE BARANGAY HEALTH WORKERS' BENEFITS AND INCENTIVES" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIAN TO ENACT

WHEREAS, the Sangguniang Panlungsod of San Carlos, Pangasinan submitted its Ordinance No. 23-12 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Legal Officer and the Local Finance Committee of the province have conducted initial review and study on said ordinance and found out that the same was enacted pursuant to Sections 16 & 458 (a) (1) (viii) and (xii) of R.A. No. 7160 and Republic Act No. 7883, otherwise known as the "The Barangay Health Workers' Benefit and Incentives Act of 1995";

WHEREAS, the local government unit should prepare a supplemental appropriation to implement the said ordinance;

WHEREAS, the subject ordinance shall take effect after compliance with the requirement of publication pursuant to Section 511 (a) of R.A. No. 7160;


