RESOLUTION NO. 89-2023

DECLARING MUNICIPAL ORDINANCE NO. 192, S-2022 OF THE SANGGUNIANG BAYAN OF BASISTA, PANGASINAN, ENTITLED "AN ORDINANCE PROVIDING FOR A COMPREHENSIVE YOUTH WELFARE AND DEVELOPMENT CODE IN THE MUNICIPALITY OF BASISTA, PANGASINAN AND FOR OTHER PURPOSES" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIAN TO ENACT

WHEREAS, the Sangguniang Bayan of Basista, Pangasinan submitted its Municipal Ordinance No. 192, Series of 2022 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Legal Officer and the Local Finance Committee have conducted initial review and study on said municipal ordinance and found out that the same was enacted in accordance with Sections 17 (b) (2) (iii) (iv) and 447 (a) (5) (xiv) of R.A. No. 7160, Section 2 (a), (b), (c) and (d) of R.A No. 8044 or "An Act Creating the National Youth Commission, Establishing a National Comprehensive and Coordinated Program on Youth Development, Appropriating Funds Therefore, and Other Purposes" and Article II, Sections 12 and 13 of the 1987 Philippine Constitution;

WHEREAS, subject ordinance shall take effect after the Sangguniang Bayan has complied with the requirement of posting pursuant to Section 59 (a) of RA 7160;

WHEREFORE, in view of the foregoing, on motion of SP Members Philip Theodore E. Cruz. and Haidee S. Pacheco and co-sponsored by SP Members Jerome Vic O. Espino, Jeanne Jinky C. Zaplan and Arthur C. Celeste, Jr., duly seconded, it was –




