APPROVING RESOLUTION NO. 23-054(A) OF THE SANGGUNIANG PANLUNGSOD OF SAN CARLOS, PANGASINAN, ENTITLED "APPROVING THE SUPPLEMENTAL INVESTMENT PROGRAM (SIP) NO. 3 FOR CALENDAR YEAR 2023 OF THE CITY OF SAN CARLOS, PROVINCE OF PANGASINAN"

WHEREAS, the Sangguniang Panlungsod of San Carlos, Pangasinan submitted its Resolution No. 23-054(A) to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No.7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said Resolution with the following findings:

1. The City Development Council of San Carlos City, Pangasinan prepared the Supplemental Investment Program (SIP) No. 3, CY 2023. This was endorsed by the Council, through CDC - ExeCom Resolution No. 05-23 (Series of 2023) dated May 3, 2023, to the Sangguniang Panlungsod for approval. This is in accordance to Sections 106, 109 and 114 of the Local Government Code of 1991; and
2. Said Supplemental Investment Program (SIP), which has a total investment requirement of ₱5,000,000.00, covers the purchase of 3 units of delivery vehicles to be funded by the National Government under project titled: Enhanced Kadiwa Financial Grant Assistance Program.
