PROVINCIAL RESOLUTION NO. 898-2023

INTERPOSING NO OBJECTION TO AND ENDORSING THE INSTALLATION, OPERATION AND MAINTENANCE OF THE SAN MANUEL SOLAR POWER PROJECT OF RE RESOURCES, INC. (RERI) LOCATED AT BARANGAY SAN ROQUE, SAN MANUEL, PANGASINAN

WHEREAS, Re Resources, Inc. (RERI), a subsidiary company of Aboitiz Power Corporation and a renewable energy developer and solar power producer, has applied for and proposed to develop and operate a 65.07MWac generation capacity of San Manuel Solar Power Project at its identified project site located at Barangay San Roque, San Manuel, Pangasinan;

WHEREAS, RERI, in its letter dated, October 04, 2023, has requested the Provincial Governor, Ramon V. Guico III through the Provincial Vice Governor, Mark Ronald DG. Lambino, a resolution of support and no objection to the proposed project;

WHEREAS, RERI has presented to the Sangguniang Panlalawigan the purpose of the project during its Regular Session held on October 9, 2023 and provided information in order to accelerate the energy program in the area apart from the socio-economic and environmental benefits that Pangasinan as host province will enjoy;

WHEREAS, RERI is cognizant to its Social Responsibility and is committed to comply with the provisions of RA 9153 or the Renewable Energy Act of 2008 as well as ER 1-94 of the Department of Energy;

WHEREAS, RA 9513, otherwise known as Renewable Energy Act of 2008 provides for the acceleration and encouragement for the exploration, development and utilization of renewable energy resources in the country;
