RESOLUTION NO. 90-2023

DECLARING MUNICIPAL ORDINANCE NO. 204, S-2022 OF THE SANGGUNIANG BAYAN OF BASISTA, PANGASINAN, ENTITLED "AN ORDINANCE PENALIZING THE SALE AND USE OF ILLEGALLY MODIFIED MOTORCYCLE MUFFLER WITHIN THE MUNICIPALITY OF BASISTA, PANGASINAN" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIANG TO ENACT

WHEREAS, the Sangguniang Bayan of Basista, Pangasinan submitted its Municipal Ordinance No. 204, Series of 2022 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Legal Officer have conducted initial review and study on said municipal ordinance and found out that the same was enacted in accordance with the Article 694 of the Civil Code of the Philippines and Section 447 (1) (iii) (2) (vi) (5) (v) of R.A. No. 7160;

WHEREAS, subject ordinance shall take effect after the Sangguniang Bayan has complied with the requirements of posting and publication pursuant to Sections 59 (b) and 511 (a) of RA 7160;




