PROVINCIAL RESOLUTION NO. 907-2023

ENDORSING TO THE DEPARTMENT OF HEALTH THE APPLICATION OF THE UMINGAN COMMUNITY HOSPITAL, PROVINCE OF PANGASINAN, FOR A PERMIT TO CONSTRUCT A NEW HEALTH FACILITY

WHEREAS, the Umingan Community Hospital, one of the 14 hospitals operated by the Provincial Government of Pangasinan, caters to patients coming from the different municipalities and other areas from nearby localities of the 6th District of Pangasinan;

WHEREAS, at present, there is a significant increase in the number of patients being serviced by the hospital;

WHEREAS, the Provincial Government of Pangasinan, through the Umingan Community Hospital, intends to construct a new health facility with the aim to have a more spacious health station in order to cater to a larger number of patients requiring medical attention and services;

WHEREAS, this Project will serve as a great step to further enhance the delivery of health and medical care services to the patients under the catchment area of the said hospital;

WHEREAS, the Umingan Community Hospital and its medical staff are capable in running and sustaining the operations of a new health facility;

WHEREAS, in line with the main thrusts of the present administration to have a mass-based health care program to accommodate all people especially the less fortunate sector of society, there is a need to support the plan of the Umingan Community Hospital to provide a more sufficient and higher level of medical and health services to its patients by its construction of a new health facility in the recently acquired lot intended for the said purpose;


