RESOLUTION NO. 911-2023

DECLARING MUNICIPAL ORDINANCE NO. 04, S-2023 OF THE SANGGUNIANG BAYAN OF BINMALEY, PANGASINAN, ENTITLED "AN ORDINANCE GRANTING FINANCIAL ASSISTANCE TO ALL SENIOR CITIZENS IN THE MUNICIPALITY OF BINMALEY TO PAY FOR THEIR ANNUAL MEMBERSHIP FEE AS CERTIFIED MEMBERS OF THE FEDERATION OF SENIOR CITIZENS OF THE PHILIPPINES (FSCAP) BINMALEY CHAPTER AND APPROPRIATING FUNDS THEREFOR" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIANG TO ENACT

WHEREAS, the Sangguniang Bayan of Binmaley, Pangasinan submitted its Ordinance No. 04-2023 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Legal Officer and Local Finance Committee of the Province have conducted initial review and study on said municipal ordinance and found out that the same was enacted in accordance with the objectives of Republic Act No. 9994, otherwise known as Expanded Senior Citizens Act of 2010 and Sections 17 (a) (b) (2) (iv), 447 (a) (5) (xvi) of R. A. No. 7160 and Section 4, Article XV of the Philippine Constitution;

WHEREAS, the Local Chief Executive of Binmaley, Pangasinan shall prepare a supplemental appropriation/budget to implement the subject ordinance;




