RESOLUTION NO. 913-2023

APPROVING MUNICIPAL RESOLUTION NO. 2023-182 OF THE SANGGUNANG BAYAN OF ALCALA, PANGASINAN, ENTITLED "APPROVING THE SUPPLEMENTAL ANNUAL INVESTMENT PROGRAM NO. 01 FOR CALENDAR YEAR 2023 OF THE MUNICIPALITY OF ALCALA, PANGASINAN"

WHEREAS, the Sangguniang Bayan of Alcala, Pangasinan submitted its SB Resolution No. 2023-182 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No.7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said SB Resolution with the following findings:

1. Subject resolution is in consonance to Sections 106, 109 and 114 of the Local Government Code (LGC) of 1991. The Municipal Development Council of Alcala, Pangasinan has identified items in their Supplemental Annual Investment Program (SAIP) No. 01. This was endorsed to the Sangguniang Bayan for approval on July 10, 2023 by the Municipal Development Council through Resolution No. 2023-01;
2. Said SAIP covers the implementation of development projects and other projects in support to the tobacco farmers in the LGU;

3. Funding support for the implementation of the same in the amount of PhP48,694,707.49 is embodied in their proposed Supplemental Budget No. 1 for Current Year 2023 which was enacted by their Sangguniang Bayan through Appropriation Ordinance No. 2023-01 on August 14, 2023; and
4. The identified projects to be funded from the shares of the LGU from the Tobacco Excise are in consonance to Local Budget Memorandum No. 84 and 86 "Collections of Excise Tax on Locally Manufactured Virginia-type cigarettes under Republic Act (RA) No. 7171, and Burley and Native Tobacco Excise Tax Pursuant to RA No. 8240" dated November 22, 2021 and December 14, 2022, respectively.




