RESOLUTION NO. 914-2023

**DECLARING THE SUPPLEMENTAL BUDGET NO. 1 FOR
CALENDAR YEAR 2023 OF ALCALA, PANGASINAN INVOLVING
A TOTAL APPROPRIATION OF P48,694,707.49, OPERATIVE IN ITS
ENTIRETY**

WHEREAS, pursuant to Republic Act No. 7160, otherwise known as the Local Government Code of 1991, the Sangguniang Panlalawigan of Pangasinan as a legislative body of the Province is empowered to review ordinances authorizing annual or supplemental appropriations of component cities and municipalities in the manner prescribed by law;

WHEREAS, the Sangguniang Bayan of Alcala, Pangasinan submitted its Supplemental Budget No. 1 for Calendar Year 2023 involving total appropriations of P48,694,707.49, which was enacted on August 14, 2023 through Appropriation Ordinance No. 2023-01;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Local Finance Committee of the Province pursuant to Section 316 of the Local Government Code of 1991, have conducted review and study on said budget with the following findings:

1. That the total fund source available for supplemental appropriation (i.e. Proceeds from Loan from the Land Bank of the Philippines (LBP) will be made actually available as required under Article 417(a) of the IRR of R.A. No. 7160, as amended by Administrative Order No. 47, and as contained in the Omnibus Term Loan Agreement between the LBP and the Municipal Government of Alcala;

2. That the utilization of appropriations from FYs 2019 and 2020 shares of the Municipality from the Burley and Native Tobacco Excise Tax Collections shall be subject to the provisions of Local Budget Memorandum Nos. 84 and 86 dated November 22, 2021 and December 14, 2022, respectively;
3. That the utilization of appropriations from 20% Development Fund shall be in accordance with the provisions of DBM - DOF- DILG Joint Memorandum Circular (JMC) No. 1 dated November 4, 2020 re "Revised Guidelines on the Appropriation and Utilization of the 20% of the Annual Internal Revenue Allotment for Development Projects";
4. That all programs, projects and activities shall be in accordance with the approved Local Development Plan and FY 2023 Supplemental Investment Program of the municipality formulated pursuant to DILG-NEDA-DBM-DOF Joint Memorandum Circular No. 1, Series of 2007, dated 08 March 2007; and
5. That all procurements to be undertaken shall be subject to the pertinent provisions of R.A. No. 9184 (The Government Procurement Reform Act) and its revised Implementing Rules and Regulations.

WHEREAS, the Sangguniang Panlalawigan after final evaluation, finds the same in order provided that the findings shall be complied with by the municipality;

WHEREFORE, in view of the foregoing, on motion of SP Members Rosary Gracia P. Perez-Tababa and Nicholi Jan Louie Q. Sison and co-sponsored by SP Members Jerome Vic O. Espino, Jeanne Jinky C. Zaplan and Arthur C. Celeste, Jr., duly seconded, it was—

RESOLVED, as it is hereby resolved, by the Sangguniang Panlalawigan in session assembled, to declare Operative in its Entirety the Supplemental Budget No. 1 for Calendar Year 2023 of Alcala, Pangasinan;

RESOLVED FURTHER, that a copy of this resolution be furnished the Office of the Sangguniang Bayan of Alcala, Pangasinan, for its information and guidance.
