RESOLUTION NO. 92-2023

APPROVING RESOLUTION NO. 63, S-2022 OF THE SANGGUNANG BAYAN OF BUGALLON, PANGASINAN, ENTITLED "APPROVING THE SUPPLEMENTAL INVESTMENT PROGRAM NO. 4 FOR FY 2022 OF THE MUNICIPALITY OF BUGALLON, PROVINCE OF PANGASINAN INVOLVING THE AMOUNT OF FIVE MILLION FOUR HUNDRED EIGHTY THOUSAND PESOS (P5,480,000.00)"

WHEREAS, the Sangguniang Bayan of Bugallon, Pangasinan submitted its SB Resolution No. 63, Series of 2022 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No.7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said SB Resolution with the following findings:

1. The Municipal Development Council of Bugallon, Pangasinan prepared their Supplemental Investment Program (SIP) No. 4 for FY 2022. This was endorsed by the Council, through MDC Resolution No. 06, Series of 2022 dated December 23, 2022, to the Sangguniang Bayan for approval;
2. Said Supplemental Investment Program, which has a total investment requirement of P5,480,000.00, covers the augmentation of funds for Personal Services (granting of Service Recognition Incentives) and Maintenance and Other Operating Expenses of some municipal offices of the LGU; and

3. Funding for the SIP is embodied in the LGU's Supplemental Budget No. 4 for FY 2022, which was enacted by their Sangguniang Bayan through Appropriation Ordinance No. 2022-05 dated December 27, 2022.


WHEREAS, the Sangguniang Panlalawigan, after final evaluation, finds the subject resolution in order, however, compliance with all the existing laws, rules and regulations shall be the responsibility of the Municipal Government of Bugallon, Pangasinan;

WHEREFORE, in view of the foregoing, on motion of SP Members Philip Theodore E. Cruz. and Haidee S. Pacheco and co-sponsored by SP Members Jerome Vic O. Espino, Jeanne Jinky C. Zaplan and Arthur C. Celeste, Jr., duly seconded, it was—


