RESOLUTION NO. 920-2023

DECLARING ORDINANCE NO. 3, S-2023 OF THE SANGGUNIANG BAYAN OF SAN QUINTIN, PANGASINAN, ENTITLED “AN ORDINANCE PRESCRIBING THE CENTRALIZED ISSUANCE OF BARANGAY CLEARANCE AND THE COLLECTION OF THE CORRESPONDING BARANGAY CLEARANCE FEE BY THE MUNICIPAL GOVERNMENT OF SAN QUINTIN, PANGASINAN IN THE APPLICATION FOR ANY BUSINESS RELATED TRANSACTIONS SUBJECT TO THE REMITTANCE OF THE AFORESAID FEES TO THE BARANGAYS CONCERNED AND THE CONDITION HEREUNDER AND FOR OTHER PURPOSES” AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIAN TO ENACT

WHEREAS, the Sangguniang Bayan of San Quintin, Pangasinan submitted its Ordinance No. 3, S-2023 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Legal Officer have conducted initial review and study on said municipal ordinance and found out that the same was enacted in accordance with Sections 129, 132 & 447 (3) (i) (viii) of R. A. No. 7160 and Section 11 (f) of RA 11032 “An Act Promoting Ease of Doing Business and Efficient Delivery of Government Services”;

WHEREAS, the subject ordinance shall take effect after compliance with the requirement of publication pursuant to Section 188 of R.A. No. 7160;


