DURING THE HAMAS TERROR ATTACK IN ISRAEL**

WHEREAS, Overseas Filipino Workers are considered modern day heroes of the country because they not only contribute to economic growth through their bulk remittances but also are figures of resilience and sacrifice;

WHEREAS, Angelyn P. Aguirre, a 33-year old Filipina caregiver from Binmaley, Pangasinan is one modern day hero of the country particularly in the Province of Pangasinan because of her heroic sacrifice not to abandon her elderly patient in a bomb shelter in Gaza;

WHEREAS, Angelyn P. Aguirre, an Overseas Filipino Worker who has been working in Israel for six years, was killed together with her employer in an attack near the Gaza Strip amid the armed conflict between Israel and the Palestinian group Hamas;




