APPROVING RESOLUTION NO. 2023-166 OF THE SANGGUNANG BAYAN OF SUAL, PANGASINAN, ENTITLED "APPROVING THE REVISED ANNUAL INVESTMENT PROGRAM (RAIP) NO. 1 CY 2023 OF SUAL, PANGASINAN INCORPORATING FIVE MILLION SIX HUNDRED THIRTY-TWO THOUSAND SEVEN HUNDRED SEVENTY-TWO & 08/100 PESOS (P5,632,772.08) UNDER THE LDRRMF-DISASTER RESPONSE PROGRAM"

WHEREAS, the Sangguniang Bayan of Sual, Pangasinan submitted its Resolution No. 2023-166 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said Resolution with the following findings:

1. The Local Development Council of Sual, Pangasinan prepared their Revised Annual Investment Program for CY 2023. This was endorsed to the Sangguniang Bayan for approval on September 7, 2023 by the Municipal Development Council thru Resolution No. 7, Series of 2023. This is in consonance to Sections 106, 109 and 114 of the Local Government Code (LGC) of 1991;

2. Said revision emanated following the Revised LDRRMIF Plan approved and adopted by the Municipal Disaster Risk Reduction and Management Council on September 6, 2023 thru MDRRMC Res. No.1 Series of 2023, utilizing the PhP5,632,772.08 from the 5% MDRRM Fund unexpended balances from LDRRMF CYs 2021 and 2022 to finance the procurement of rice and relief assistance for the LGU's disaster response program. This was subsequently
3. adopted by the Sangguniang Bayan thru Resolution No. 2023-164 on September 13, 2023; and
4. The Revised AIP is in accordance to Item 6.5 of the NDRRMC-DBM-DILG JMC No. 2013-1 dated March 25, 2013, to quote: 'NDRRMC-DBM-DILG JMC No. 2013-1 xxxx 6.5. The unexpended balances of the LDRRMF may be released and utilized for new expenditure items upon submission of a revised AIP as approved by the local Sanggunian and Local Chief Executive (LCE) upon recommendation of the LDRRMC in accordance with the approved LDRRMP.'

WHEREAS, the Sangguniang Panlalawigan, after final evaluation, finds the subject resolution in order, however, compliance with all the existing laws, rules and regulations shall be the responsibility of the Municipal Government of Sual, Pangasinan;

WHEREFORE, in view of the foregoing, on motion of SP Members Napoleon C. Fontelera, Jr. and Apolonia DG. Bacay and co-sponsored by SP Members Jerome Vic O. Espino, Jeanne Jinky C. Zaplan and Arthur C. Celeste, Jr., duly seconded, it was—

RESOLVED, by the Sangguniang Panlalawigan in session assembled, to approve Resolution No. 2023-166 of the Sangguniang Bayan of Sual, Pangasinan, entitled "Approving the Revised Annual Investment Program (RAIP) No. 1 CY 2023 of Sual, Pangasinan incorporating Five Million Six Hundred Thirty-Two Thousand Seven Hundred Seventy-Two & 08/100 Pesos (P5,632,772.08) under the LDRRMF-Disaster Response Program"
