RESOLUTION NO. 932-2023

DECLARING ORDINANCE NO. 2023-024 OF THE SANGGUNIANG BAYAN OF STA. BARBARA, PANGASINAN, ENTITLED "AN ORDINANCE CREATING THE MUNICIPAL TASK FORCE AND TECHNICAL WORKING GROUP, AND ADOPTING AND IMPLEMENTING THE 'BANTAY ASF SA BARANGAY' OR THE 'BABAY ASF PROGRAM'", AND PROVIDING POWERS THEREOF, AND FOR OTHER PURPOSES" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIAN TO ENACT

WHEREAS, the Sangguniang Bayan of Sta. Barbara, Pangasinan submitted its Ordinance No. 2023-024, to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Legal Officer and the Local Finance Committee of the province have conducted initial review and study on said ordinance and found out that the same was enacted in accordance with Sections 16, 17 (a) (b) (2) (iii) & 447 (a) (5) (xii) of R. A. No. 7160; Republic Act No. 10611, otherwise known as the "Food Safe Act of 2013; Republic Act No. 6296, or the "The Meat Inspection Code of the Philippines"; and Department of Agriculture Administrative Order No. 07, Series of 2021, entitled "Implementing Guidelines for the Bantay ASF sa Barangay Program";

WHEREAS, the subject ordinance shall take effect after compliance with the requirement of publication pursuant to Section 511 (a) of R.A. No. 7160;
