RESOLUTION NO. 938-2023

APPROVING RESOLUTION NO. 243, S-2023 OF THE SANGGUNANG BAYAN OF UMINGAN, PANGASINAN, ENTITLED "APPROVING SUPPLEMENTAL INVESTMENT PROGRAM NO. 2, CY 2023 IN THE TOTAL AMOUNT OF TWO MILLION TWO HUNDRED FIFTY FIVE THOUSAND NINE HUNDRED ELEVEN PESOS AND NINETY ONE CENTAVOS (P2,255,911.91) TO BE ALLOCATED AND UTILIZED FOR SOLID WASTE MANAGEMENT"

WHEREAS, the Sangguniang Bayan of Umingan, Pangasinan submitted its Resolution No. 243, S-2023 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said Resolution with the following findings:

1. The Municipal Development Council of Umingan, Pangasinan has formulated and endorsed the municipality's Supplemental Investment Program No. 2 through MDC Resolution No. 2, S-2022 dated July 4, 2023 to the Sangguniang Bayan for approval. This is in pursuance to Sections 106, 109, 114 of the Local Government Code of 1991;
2. The Supplemental Investment Program with an investment requirement amounting to PhP2,255,911.91 covers the implementation of their Solid Waste Management Program (Improvement of Material Recovery Facility) of LGU Umingan; and

3. The Sangguniang Bayan enacted Supplemental Budget No. 2 through Appropriation Ordinance No.2, S-2023 dated September 4, 2023 to support the implementation of the Supplemental Investment Program of the municipality.

WHEREAS, the Sangguniang Panlalawigan, after final evaluation, finds the subject resolution in order, however, compliance with all the existing laws, rules and regulations shall be the responsibility of the Municipal Government of Umingan, Pangasinan;

WHEREFORE, in view of the foregoing, on motion of SP Members Noel C. Bince and Salvador S. Perez, Jr. and co-sponsored by SP Members Jerome Vic O. Espino, Jeanne Jinky C. Zaplan and Arthur C. Celeste, Jr., duly seconded, it was—

RESOLVED, by the Sangguniang Panlalawigan in session assembled, to approve Resolution No. 243, S-2023 of the Sangguniang Bayan of Umingan, Pangasinan, entitled “Approving Supplemental Investment Program No. 2, CY 2023 in the total amount of Two Million Two Hundred Fifty Five Thousand Nine Hundred Eleven Pesos and Ninety One Centavos (P2,255,911.91) to be Allocated and Utilized for Solid Waste Management”
