**APPROVING THE ANNUAL INVESTMENT PROGRAM (AIP) OF

WHEREAS, the Annual Investment Program of the Province of Pangasinan embodies the priority programs, projects and activities that address the basic sectors of development to be implemented in CY 2024;

WHEREAS, the AIP of the Province for CY 2024 is aligned with the priorities of the National Government embodied in the AMBISYON NATIN 2040, 8-Point Socio-Economic Agenda of the President, Sustainable Development Goals and to the economic and social plans and strategies in relation to the COVID-19 pandemic;

WHEREAS, the AIP of the Province for CY 2024 is geared towards the attainment of the vision and mission of the provincial government and embodies the priority programs, projects and activities under the four basic services of development such as General Public Services, Social Services, Economic Services and Other Purposes, the Development Projects funded by 20% Development Fund, Disaster Risk Reduction and Management Projects/Programs and Investment Priority Areas, which when implemented would have great impact on the economy and on the lives of the Pangasinenses particularly the poor and the marginalized sector;

WHEREAS, funding for the implementation of the AIP 2024 shall come from Provincial Government and other fund sources;

WHEREAS, the AIP of the Province for CY 2024 will serve as a vehicle for the delivery of the basic socio-economic services and facilities for the progress and development of Pangasinan;
