PROVINCIAL RESOLUTION NO. 945-2023

AUTHORIZING THE PROVINCIAL GOVERNOR, RAMON V. GUICO III, TO ENTER INTO AND SIGN A MEMORANDUM OF UNDERSTANDING WITH THE PHILIPPINE MEDICAL SOCIETY OF GREATER KANSAS CITY (PMSGKC) AND THE PHILIPPINE NURSES ASSOCIATION OF GREATER KANSAS CITY (PNAGKC) FOR THE CONDUCT OF A MEDICAL, SURGICAL AND DENTAL MISSION ON JANUARY 24-29, 2024

WHEREAS, the Philippine Medical Society of Greater Kansas City (PMSGKC) and the Philippine Nurses Association of Greater Kansas City (PNAGKC) are both professional organizations based in the United States of America which have been conducting medical missions in different parts of the country;

WHEREAS, the Provincial Government of Pangasinan, through the Western Pangasinan District Hospital, in collaboration with the PMSGKC and PNAGKC will join efforts in conducting a 6-day medical, surgical and dental mission on January 24-29, 2024;

WHEREAS, the duties and responsibilities of both parties in the conduct of the medical, surgical and dental mission are already defined in the Memorandum of Understanding;

WHEREAS, it is to the best interest of the Provincial Government of Pangasinan to authorize the Provincial Governor to sign the Memorandum of Understanding to further augment the need for free medical, surgical and dental services to indigent people of Bolinao and Alaminos City, Pangasinan;

WHEREAS, for the above purpose, a Memorandum of Agreement shall be entered into and signed between the Province of Pangasinan, represented by Governor Ramon V. Guico III and the Philippine Medical Society of Greater Kansas City
