**PROVINCIAL RESOLUTION NO. 946-2023**

**ADOPTING THE PEACE AND ORDER AND PUBLIC SAFETY PLAN (POPSPlan) 2023-2025 OF THE PROVINCE OF PANGASINAN**

**WHEREAS**, presented to the Sangguniang Panlalawigan for consideration is the Provincial Peace and Order and Public Safety Plan (POPSP) and Local Anti-Drug Plan of Action (LAPDA) of the Province of Pangasinan for Calendar Years 2023-2025 as endorsed by the Joint Provincial Peace and Order Council (PPOC) – Provincial Anti-Drug Abuse Council (PADAC) through PPOC-PADAC Resolution No. 01, S-2023;

**WHEREAS**, the POPSPPlan represents the three-year planning and budgeting document of the Provincial Government of Pangasinan which identifies the needed programs, projects and activities of the Province geared towards delivering essential basic services to the people in order to further maintain peace and order and public safety;

**WHEREAS**, the POPSPPlan is designed to focus on present major issues and problems in the Province which include, among others, strategies on crime and disorder, anti-illegal drugs situation, insurgency/armed conflict, threats to the environment and human security, and road and vehicle safety;

**WHEREAS**, the POPSPPlan also includes implementation of programs, projects and activities toward decreasing the incidence of rape, theft and robbery; decreasing the number of drug personalities; maintaining and strengthening the insurgency free status of the province; and decreasing the incidence of road traffic accidents in the province;

**WHEREAS**, the POPSPPlan shall serve as the roadmap of the Province in further attaining a safe, secure, peaceful and progressive Pangasinan;


