PROVINCIAL RESOLUTION NO. 950-2023

REQUESTING PNP CHIEF DIRECTOR GENERAL BENJAMIN C. ACORDA TO NAME THE PROPERTY OWNED BY THE PHILIPPINE NATIONAL POLICE COVERED UNDER TAX DECLARATION NO. 2018-01-03476 INTO CAMP GONZALO C. DOMONDON SITUATED IN BRGY. POBLACION, ALAMINOS CITY, PANGASINAN

WHEREAS, PNP Memorandum Circular No. 2011-025 entitled "Policy, Guidelines and Procedures in Naming or Renaming of PNP CAMPS AND FACILITIES" provides that "For properties donated by local governments with the exception of barangays whether or not deed of donation provides the desired name of the donated property by the local government, the recipient of the donated property by the local government, the recipient unit shall coordinate with the Local Government Unit (LGU) for the completion of the documentary requirements and issuance of resolution as legal basis for the naming. xxx";

WHEREAS, the Philippine National Police has a parcel of land situated in Brgy. Poblacion, Alaminos City, Pangasinan consisting of 3,076 sq. m. known as Cadastral Lot No. 709 covered by tax declaration 2018-01-03476 where the Pangasinan 1st Provincial Mobile Force Company Headquarters, Alaminos City Police Station and CIDG SATT-1 are established;

WHEREAS, the described land was previously owned by the Spouses Mr. Gonzalo C. Domondon and Mrs. Catalina C. Domondon evidenced by Original Certificate Title 13021 issued in their favor by the Register of Deeds for the Province of Pangasinan in accordance with the Land Registration Act;

WHEREAS, with the earnest and ardent desire of Mr. and Mrs. Gonzalo C. Domondon to see established within the City the then Philippine Constabulary, now the Philippine National Police, as a means to ensure the protection of the lives and properties of its inhabitants and for a better promotion of peace and order within its confines, said parcel of land was voluntarily given, granted and donated by way of Deed of Donation executed and signed on June 11, 1976;

WHEREAS, it is the intent of the Province of Pangasinan under the administration of the Philippine National Police as a manifestation of recognition and gratitude for the kind benevolence and wholeheartedly sympathy of the previous owner Mr. and Mrs. Gonzalo Domondon and family to our public servant-law enforcement officers worthy of high praise and emulation by way of naming the property into CAMP GONZALO C. DOMONDON;

WHEREFORE, upon motion of SP Member Apolonia DG. Bacay and duly seconded, it was-

RESOLVED, by the Sangguniang Panlalawigan in session assembled, to request PNP Chief Director General Benjamin C. Acorda, through PNP Regional Director BGen John C. Chua and PNP Provincial Director PCOL Jeff E. Fanged, to name the property owned by the Philippine National Police covered by Tax Declaration No. 2018-01-03476 into Camp Gonzalo C. Domondon situated in Brgy. Poblacion, Alaminos City, Pangasinan;
