APPROVING SB RESOLUTION NO. 73, S-2023 OF THE SANGGUNIANG BAYAN OF BANI, PANGASINAN, ENTITLED "APPROVING THE SUPPLEMENTAL INVESTMENT PROGRAM NO. 03, CY 2023 AMOUNTING TO SIXTEEN MILLION ONE HUNDRED NINETY EIGHT THOUSAND SEVEN HUNDRED FIFTEEN PESOS AND FORTY-ONE CENTAVOS (P16,198,715.41) FUNDED BY THE GENERAL FUND OF THE MUNICIPALITY OF BANI, PANGASINAN"

WHEREAS, the Sangguniang Bayan of Bani, Pangasinan submitted its SB Resolution No. 73, S-2023 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No.7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said SB Resolution with the following findings:

1. Subject resolution is in consonance to Sections 106, 109 and 114 of the Local Government Code (LGC) of 1991. The Local Development Council of Bani, Pangasinan had identified items in their Supplemental Investment Program (SIP) No. 3 for CY 2023. This was endorsed to the Sangguniang Bayan for approval on August 2, 2023 by the Municipal Development Council through Resolution No. 2023-05;
2. Said SIP covers fund augmentation for Personal Services, Maintenance and Other Operating Expenses, and Capital Outlay of some municipal government offices, and the implementation of priority development programs/projects of the LGU; and

3. Funding support for the implementation of the same in the amount of PhP16,198,715.41 is embodied in their proposed Supplemental Budget No. 3 for Calendar Year 2023 which was enacted by their Sangguniang Bayan through Appropriation Ordinance No. 03-S.2023 on August 7, 2023 and approved by the Municipal Mayor on August 9, 2023.


WHEREAS, the Sangguniang Panlalawigan, after final evaluation, finds the subject resolution in order, however, compliance with all the existing laws, rules and regulations shall be the responsibility of the Municipal Government of Bani, Pangasinan;

WHEREFORE, in view of the foregoing, on motion of SP Members Napoleon C. Fontelera, Jr. and Apolonia DG. Bacay and co-sponsored by SP Members Jerome Vic O. Espino, Jeanne Jinky C. Zaplan and Arthur C. Celeste, Jr., duly seconded, it was—


RESOLVED, by the Sangguniang Panlalawigan in session assembled, to approve SB Resolution No. 73, S-2023 of the Sangguniang Bayan of Bani, Pangasinan, entitled “Approving the Supplemental Investment Program No. 03, CY 2023 amounting to Sixteen Million One Hundred Ninety Eight Thousand Seven Hundred Fifteen Pesos and Forty-One Centavos (P16,198,715.41) funded by the General Fund of the Municipality of Bani, Pangasinan”;
