## **RESOLUTION NO. 959-2023**

DECLARING MUNICIPAL ORDINANCE NO. 9, S-2023 OF THE SANGGUNIANG BAYAN OF MABINI, PANGASINAN, ENTITLED "AN ORDINANCE GRANTING BIRTHDAY CASH GIFT OF FIVE HUNDRED PESOS (P500.00) TO SENIOR CITIZEN OF THE MUNICIPALITY OF MABINI, PANGASINAN AND APPROPRIATING NECESSARY FUNDS THEREOF" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIAN TO ENACT

WHEREAS, the Sangguniang Bayan of Mabini, Pangasinan submitted its Ordinance No. 9, S-2023 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Legal Officer and the Local Finance Committee of the Province have conducted initial review and study on said municipal ordinance and found out that the same was enacted in accordance with the objectives of Republic Act No. No. 9994, otherwise known as "Expanded Senior Citizens Act of 2010; Sections 17 (a) (b) (2) (iv) & 447 (a) (5) (xvi) of R. A. No. 7160 and Section 4, Article XV of the Philippine Constitution;

WHEREAS, subject ordinance shall take effect after compliance with the requirement of posting pursuant to Section 59 of RA No. 7160;
