RESOLUTION NO. 96-2023

APPROVING SB RESOLUTION NO. 154-2022 OF THE SANGGUNIANG BAYAN OF MANGATAREM, PANGASINAN, ENTITLED "APPROVING THE SUPPLEMENTAL INVESTMENT PROGRAM NO. 3 FOR CY 2022 OF THE MUNICIPALITY OF MANGATAREM, PANGASINAN"

WHEREAS, the Sangguniang Bayan of Mangatarem, Pangasinan submitted its SB Resolution No. 154-2022 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said SB Resolution with the following findings:

1. The Municipal Development Council – Executive Committee of Mangatarem, Pangasinan prepared their Supplemental Investment Program (SIP) No. 3 for CY 2022. This was endorsed by the Council, through MDC ExeCom Resolution No. 4, Series of 2022 dated December 22, 2022, to the Sangguniang Bayan for approval;
2. Said Supplemental Investment Program, which has a total investment requirement of ₱10,677,500.00, covers the augmentation of funds for Personal Services (to include the granting of Collective Negotiation Agreement Incentives and Service Recognition Incentives to qualified officials of employees of the LGU) and Maintenance and Other Operating Expenses (to include financial and rice assistance) of the LGU, and implementation of development projects of the Municipal Government; and

3. Funding for this Supplemental AIP is embodied in their Supplemental Budget No. 3 for FY 2022, which was enacted by their Sangguniang Bayan through Appropriation Ordinance No. 04, Series of 2022 dated December 27, 2022.


WHEREAS, the Sangguniang Panlalawigan, after final evaluation, finds the subject resolution in order, however, compliance with all the existing laws, rules and regulations shall be the responsibility of the Municipal Government of Mangatarem, Pangasinan;


