RESOLUTION NO. 961-2023

APPROVING SB RESOLUTION NO. 281-2023 OF THE SANGGUNANG BAYAN OF MANGATAREM, PANGASINAN, ENTITLED “APPROVING THE SUPPLEMENTAL INVESTMENT PROGRAM NO. 2 FOR CY 2023 OF THE MUNICIPALITY OF MANGATAREM, PANGASINAN”

WHEREAS, the Sangguniang Bayan of Mangatarem, Pangasinan submitted its SB Resolution No. 281-2023 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No.7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said SB Resolution with the following findings:

1. The Municipal Development Council of Mangatarem, Pangasinan prepared their Supplemental Investment Program (SIP) No. 2 for CY 2023. This was endorsed by the Council, through MDC ExeCom Resolution No. 03, Series of 2023 dated September 26, 2023, to the Sangguniang Bayan for approval. This is in accordance to Sections 106, 109 and 114 of the Local Government Code of 1991;
2. Said Supplemental Investment Program, which has a total investment requirement of ₱17,784,110.73, covers the augmentation of funds for Personal Services (PS), Maintenance and Other Operating Expenses (MOOE) of some offices of the LGU, and implementation of development projects of the municipality;

3. The projects proposed for funding from the 20% Development Fund, in the amount of P15,900,000.00, are based on the Joint DBM-DOF-DILG Memorandum Circular No. 1 dated November 4, 2020 (Revised Guidelines on the Appropriation and Utilization of the 20% of the IRA for Development Projects); and
4. Funding for the Supplemental Investment Program is embodied in the LGU's Supplemental Budget No. 02 for FY 2023, which was enacted by their Sangguniang Bayan through Appropriation Ordinance No. 02, Series of 2023 dated September 28, 2023 and approved by the Municipal Mayor on October 2, 2023.


WHEREAS, the Sangguniang Panlalawigan, after final evaluation, finds the subject resolution in order, however, compliance with all the existing laws, rules and regulations shall be the responsibility of the Municipal Government of Mangatarem, Pangasinan;

WHEREFORE, in view of the foregoing, on motion of SP Members Philip Theodore E. Cruz and Haidee S. Pacheco and co-sponsored by SP Members Jerome Vic O. Espino, Jeanne Jinky C. Zaplan and Arthur C. Celeste, Jr., duly seconded, it was—


