## **RESOLUTION NO. 969-2023**

DECLARING MUNICIPAL ORDINANCE NO. 03-08072023 OF THE SANGGUNIANG BAYAN OF POZORRUBIO, PANGASINAN, ENTITLED "AN ORDINANCE INSTITUTIONALIZING AN INTEGRATED PRE-NATAL, MATERNAL, NEONATAL AND EARLY CHILDHOOD DEVELOPMENT INTERVENTION PACKAGE FOR THE FIRST ONE THOUSAND (1000) DAYS OF LIFE OF A CHILD IN THE MUNICIPALITY OF POZORRUBIO, PANGASINAN" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIAN TO ENACT
