DECLARING MUNICIPAL ORDINANCE NO. 03-08072023 OF THE SANGGUNIANG BAYAN OF POZORRUBIO, PANGASINAN, ENTITLED “AN ORDINANCE INSTITUTIONALIZING AN INTEGRATED PRE-NATAL, MATERNAL, NEONATAL AND EARLY CHILDHOOD DEVELOPMENT INTERVENTION PACKAGE FOR THE FIRST ONE THOUSAND (1000) DAYS OF LIFE OF A CHILD IN THE MUNICIPALITY OF POZORRUBIO, PANGASINAN” AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIAN TO ENACT

WHEREAS, the Sangguniang Bayan of Pozorrubio, Pangasinan submitted its Ordinance No. 03-08072023 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Legal Officer and the Provincial Health Officer have conducted initial review and study on said municipal ordinance and found out that the same was enacted in accordance with Sections 16 & 17 (b) (2) (iii) (iv) of R. A. No. 7160; Department of Health (DOH) Administrative Order 2008-0029, “Implementing Health Reforms for Rapid Reduction of Maternal and Neonatal Mortality; Department of Health (DOH) Administrative Order 2010-0036, “The Aquino Health Agenda: Achieving Universal Health Care for All Filipinos”; Republic Act No. 10410 “ An Act Recognizing The Age From Zero (0) To Eight (8) Years As The First Crucial Stage of Educational Development And Strengthening The Early Childhood Care And Development System, Appropriating Funds Therefor And For Other Purposes”; Memorandum Circular No. 2006-91, “New Standards in the Accreditation of Center-Based ECCD Programs and Service Providers”; and Republic Act 11148, “An Act of
