**RESOLUTION NO. 97-2023**

**DECLARING THE SUPPLEMENTAL BUDGET NO. 3 FOR  
CALENDAR YEAR 2022 OF MANGATAREM, PANGASINAN  
INVOLVING A TOTAL APPROPRIATION OF P10,677,500.00,  
OPERATIVE IN ITS ENTIRETY**

**WHEREAS**, pursuant to Republic Act No. 7160, otherwise known as the Local Government Code of 1991, the Sangguniang Panlalawigan of Pangasinan as a legislative body of the Province is empowered to review ordinances authorizing annual or supplemental appropriations of component cities and municipalities in the manner prescribed by law;

**WHEREAS**, the Sangguniang Bayan of Mangatarem, Pangasinan submitted its Supplemental Budget No. 03 for Calendar Year 2022 involving total appropriations of Php10,677,500.00, which was enacted on December 27, 2022 through Appropriation Ordinance No. 04, Series of 2022;

**WHEREAS**, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Local Finance Committee of the Province pursuant to Section 316 of the Local Government Code of 1991, have conducted review and study on said budget with the following findings:

1. That the grant for Service Recognition Incentive (SRI) for FY 2022 to all municipal officials, regular and casual employees of the municipality shall be in accordance with the provisions of Administrative Order No. 01 dated December 16, 2022;
2. That the grant for Collective Negotiation Agreement (CNA) for FY 2022 to all municipal officials, regular and casual employees shall be in accordance with the provisions of Budget Circular No. 2022-3 of the Department of Budget and Management dated October 19, 2022;

3. That the grant for Rice Assistance for FY 2022 to all municipal officials, regular and casual employees of the municipality shall be in accordance with the provisions of Administrative Order No. 02 dated December 16, 2022;
4. That all procurement to be undertaken shall be subject to the pertinent provisions of R.A. No. 9184 (The Government Procurement Reform Act) and its revised Implementing Rules and Regulations;
5. That all programs, projects and activities shall be in accordance with the approved Local Development Plan and FY 2022 Supplemental Investment Program of the municipality formulated pursuant to DILG-NEDA-DBM-DOF Joint Memorandum Circular No. 1, Series of 2007 dated March 2007; and
6. That the funding sources for the subject Supplemental Budget were determined in accordance with Section 321 of R. A. No. 7160 and Article 417(a) of its IRR as amended by Administrative Order No. 47 dated April 12, 1993.

**WHEREAS**, the Sangguniang Panlalawigan after final evaluation, finds the same in order provided that the findings shall be complied with by the municipality;

**WHEREFORE**, in view of the foregoing, on motion of SP Members Philip Theodore E. Cruz. and Haidee S. Pacheco and co-sponsored by SP Members Jerome Vic O. Espino, Jeanne Jinky C. Zaplan and Arthur C. Celeste, Jr., duly seconded, it was—

**RESOLVED**, as it is hereby resolved, by the Sangguniang Panlalawigan in session assembled, to declare Operative in its Entirety the Supplemental Budget No. 03 for Calendar Year 2022 of Mangatarem, Pangasinan;
