**DECLARING MUNICIPAL ORDINANCE NO. 04-08072023 OF THE SANGGUNIANG BAYAN OF POZORRUBIO, PANGASINAN, ENTITLED “AN ORDINANCE REGULATING THE USE OF PUBLIC PARKS, PLAZAS, MONUMENTS, AND OTHER PUBLIC PROPERTIES DEVOTED FOR PUBLIC USE IN THE MUNICIPALITY OF POZORRUBIO, PANGASINAN AND PRESCRIBING PENALTIES FOR VIOLATION THEREOF” AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIAN TO ENACT**
