RESOLUTION NO. 973-2023

APPROVING RESOLUTION NO. 66, S-2023 OF THE SANGGUNIANG BAYAN OF VILLASIS, PANGASINAN, ENTITLED "APPROVING THE ANNUAL INVESTMENT PROGRAM (AIP) FOR CALENDAR 2024 AND OTHER ACTIVITIES RELATED TO THE ANNUAL BUDGET IN THE AMOUNT OF TWO HUNDRED EIGHTY SIX MILLION FOUR HUNDRED ONE THOUSAND THREE HUNDRED TWENTY EIGHT PESOS (P286,401,328.00) OF THE MUNICIPALITY OF VILLASIS, PANGASINAN"

WHEREAS, the Sangguniang Bayan of Villasis, Pangasinan submitted its SB Resolution No. 66, S-2023 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No.7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said SB Resolution with the following findings:

1. Subject Resolution is approving the Annual Investment Program (AIP) for calendar year 2024. This was endorsed by the Municipal Development Council to the Sangguniang Bayan for approval on July 6, 2023 through MDC Resolution No. 04-2023. This is in consonance to Sections 106,109 and 114 of the Local Government Code (LGC) OF 1991;
2. The said AIP of Villasis, Pangasinan is categorized into general public, social, economic, and other services. It likewise covers: (a) all the regular budgetary items for the operations of the different municipal offices

broken down into PS, MOOE, Financial Expenses and Capital Outlay; (b) the priority development programs/projects and those to be funded by the 20% development fund, and; (c) disaster risk reduction management programs/projects/activities of the municipality. It further includes the following: 1) Gender and Development Plan, Peace and Order Plan and Anti-Drug Abuse Council Action Plan, Local Nutrition Action Plan, and Tourism/Cultural Development Plan, Climate Change Action Plan, Local Youth Development Plan, Annual Procurement Plan, and; 2) list of programs/projects/activities for the Local Council for Protection of Children, Senior Citizens and Persons with Disabilities, PPAs to combat Acquired Immune Deficiency Syndrome. It is recommended however that the LGU shall use the new formulated prescribed AIP Summary Form in accordance to Local Budget Memorandum No. 87 dated June 9, 2023;

3. The proposed AIP has a total investment requirement of Php286,401,328.00 which will be funded from the municipality's proposed 2024 Annual Budget enacted on July 18, 2023 through Appropriation Ordinance No. 03;
4. The LGU has also identified programs/projects/activities responsive to climate change and tagged its corresponding expenditures in their AIP. This is in pursuance to DBM-CCC-DILG Joint Memorandum Circular No. 2015-01 dated July 23, 2015; and
5. The Gender and Development Plan of the municipality has been reviewed by the Department of the Interior and Local Government (DILG) and was found to be fully compliant in form and contents with the provisions of the Joint Memo Circular of 2016-01: Amendments to JMC 2013-01 re: Guidelines on Localization of the Magna Carta of Women as per attached Certificate of Review and Endorsement of the DILG dated December 16, 2022.

WHEREAS, the Sangguniang Panlalawigan, after final evaluation, finds the subject resolution in order, however, compliance with all the existing laws, rules and regulations shall be the responsibility of the Municipal Government of Villasis, Pangasinan;

WHEREFORE, in view of the foregoing, on motion of SP Members Rosary Gracia P. Perez-Tababa and Nicholi Jan Louie Q. Sison and co-sponsored by SP Members Jerome Vic O. Espino, Jeanne Jinky C. Zaplan and Arthur C. Celeste, Jr., duly seconded, it was –




