PROVINCIAL RESOLUTION NO. 982-2023

INVITING THE PNP SISON MUNICIPAL POLICE STATION AND DPWH-PANGASINAN 3RD DISTRICT ENGINEERING OFFICE TO A QUESTION HOUR OF THE SANGGUNIAN PANLALAWIGAN DURING ITS NOVEMBER 20, 2023 REGULAR (PHYSICAL) SESSION TO APPRISE THE BODY REGARDING THE UNFORTUNATE INCIDENTS CAUSED BY POTHOLES/OPEN MANHOLES ALONG THE NATIONAL HIGHWAY OF SISON, PANGASINAN

WHEREAS, Presidential Decree No. 702 provides that the construction, rehabilitation, betterment, improvement and maintenance of rural roads and bridges are of paramount importance, as they are the traffic generators that provide the link to the main arteries of transportation from the rural to the urban areas;

WHEREAS, there is a need to provide the people of Pangasinan better and safer road for transportation purposes, travels and other economic activities;

WHEREAS, some national, provincial and barangay roads may have defects posing imminent danger especially potholes that would require corrective action that will be promptly handled by the concerned agencies;

WHEREAS, open manholes and potholes including missing manhole cover, curbs, inlets/drainage gratings along the roads in the province shall be immediately repaired and replaced;

WHEREAS, a Police Blotter Entry No. 2023-11-0827 was recorded in the Municipal Police Station of Sison, Pangasinan that a vehicular accident occurred when a motorcycle ran over a deep pothole and collided with an unidentified vehicle leading to death of a certain driver and its backride along the national highway of Cauringan, Sison, Pangasinan;

WHEREFORE, in view of the foregoing, on motion of SP Member Nicholi Jan Louie Q. Sison, duly seconded, it was-


