PROVINCIAL RESOLUTION NO. 987-2023

URGING ALL LOCAL GOVERNMENT UNITS IN THE PROVINCE OF PANGASINAN TO CREATE A PLANTILLA POSITION OF ENVIRONMENT AND NATURAL RESOURCES OFFICER (ENRO) WITHIN THEIR RESPECTIVE LOCALITIES

WHEREAS, Section 76 of RA No. 7160, otherwise known as the Local Government Code of 1991, states that every Local Government Unit shall design and implement its own organizational structure staffing pattern taking into consideration its services requirements and financial capability subject to minimum standards and guidelines prescribed by the Civil Services Commission;

WHEREAS, Section 484 thereof also states that the Municipal/City Mayor may appoint an Environment and Natural Resources Officer;

WHEREAS, the Environment and Natural Resources Officer shall formulate measures for consideration of the Sanggunian and provide technical assistance and support to the Governor or Mayor to ensure sustainable use, development, management protection and preservation of the environment and natural resources;

WHEREAS, presently, the functions of an Environment and Natural Resources Officer are assigned to Municipal/City Planning and Development Officer (M/CPDO) or the Municipal/City Disaster Risk Reduction Management Officer (M/CDRRMO) who are likewise burdened with voluminous work assignments;

WHEREAS, the Sangguniang Panlalawigan recognizes the importance of having an Environment and Natural Resources Officer in the municipalities and cities of the Province, as local government units have wider and more definite tasks in maintaining sustainable environmental and natural resources' projects, programs and activities;
