**PROVINCIAL RESOLUTION NO. 988-2023**

**AUTHORIZING THE PROVINCIAL GOVERNOR, RAMON V. GUICO III, TO ENTER INTO AND SIGN A MEMORANDUM OF AGREEMENT WITH THE SOCIETY OF GYNECOLOGIC ONCOLOGISTS OF THE PHILIPPINES, INC. (SGOP) AND THE BAYAMBANG DISTRICT HOSPITAL FOR THE CONDUCT OF A JOINT ONCOGYNECOLOGICAL MEDICAL AND SURGICAL MISSION IN THE PROVINCE OF PANGASINAN**

**WHEREAS**, the Society of Gynecologic Oncologists of the Philippines, Inc. (SGOP) is a registered and exemplary organization of gynecologic oncologists and specialists of related disciplines committed for the continuous upgrading of the standards of practice, teaching, and research in the field of gynecologic oncology in the Philippines;

**WHEREAS**, the Provincial Government of Pangasinan, through the Bayambang District Hospital, in partnership with the Society of Gynecologic Oncologists of the Philippines, Inc. will join efforts in conducting 1-2 day/s Oncogynecological Medical and Surgical Mission on November 25 and/or 26, 2023;

**WHEREAS**, the Society of Gynecologic Oncologists of the Philippines, Inc. shall conduct the identification of patients for surgery and cervical cancer screening purposely for the said mission;

**WHEREAS**, the Bayambang District Hospital shall provide its health care facilities and equipment and a suitable area for the loading and unloading of equipment and medical supplies of the said medical team for the duration of the aforesaid medical mission;

**WHEREAS**, further, the Bayambang District Hospital, through its Medical Residents, shall monitor post-operative patients after the said mission until the last patient is discharged from the hospital;

**WHEREAS**, the duties and responsibilities of the parties are stipulated in the Memorandum of Agreement which is made an integral part of this resolution;

**WHEREAS**, it is to the best interest of the Provincial Government of Pangasinan to authorize the Provincial Governor to sign the Memorandum of Agreement to further augment the need for medical and health care services of the Province;

**WHEREAS**, for the above purpose, a Memorandum of Agreement shall be entered into and signed between the Province of Pangasinan, represented by Governor Ramon V. Guico III, the Society of Gynecologic Oncologists of the Philippines, Inc., represented by its Medical Mission Coordinator, Dr. Gladdy Maura G. Facun, and the Bayambang District Hospital, represented by its Chief of Hospital, Dr. Athena Marie C. Merrera;

**NOW, THEREFORE**, on motion of SP Member Shiela Marie F. Baniqued, duly seconded, it was –

**RESOLVED**, by the Sangguniang Panlalawigan in session assembled to authorize, as he is hereby authorized, the Provincial Governor, Ramon V. Guico III, to enter into and sign a Memorandum of Agreement with the Society of Gynecologic Oncologists of the Philippines, Inc. and the Bayambang District Hospital for the conduct of a joint Oncogynecological Medical and Surgical Mission in the Province of Pangasinan;
