PROVINCIAL RESOLUTION NO. 990-2023

AUTHORIZING THE PROVINCIAL GOVERNOR, RAMON V. GUICO III, TO ENTER INTO AND SIGN THE MEMORANDUM OF UNDERSTANDING WITH THE PHILIPPINE BAND OF MERCY (PBM) FOR THE IMPLEMENTATION AND PROMOTION OF THE CLEFT CARE PROGRAM IN THE PROVINCE OF PANGASINAN

WHEREAS, the Philippine Band of Mercy (PBM) is a non-stock, non-profit and non-government organization established in 1937 which conducts a program of medical and surgical missions in the country;

WHEREAS, the PBM has chosen the Province of Pangasinan as one of its target areas to spread out its mission of providing free cleft surgical services to underprivileged children born with cleft lip/palate deformities which will be held on a schedule to be agreed upon by the PBM and the Pangasinan Provincial Hospital, Western Pangasinan District Hospital and Mangatarem District Hospital, depending on the number of patients in Pangasinan;

WHEREAS, the program would greatly help in promoting the well-being of less-fortunate Pangasinenses especially in boosting the self-esteem and confidence of those harelip and cleft palate patients from various parts of the Province;

WHEREAS, it is to the best interest of the Provincial Government of Pangasinan to enter into and sign the Memorandum of Understanding to further augment the medical and health services need of the people of Pangasinan;

WHEREAS, for the above purpose, the Memorandum of Understanding shall be entered into and signed between the Province of Pangasinan, represented by Governor Ramon V. Guico III, and the PBM, represented by its Executive Director, Ms. Persida G. Benedictos;
