APPROVING RESOLUTION NO. 2023-150 OF THE SANGGUNANG BAYAN OF SUAL, PANGASINAN, ENTITLED “APPROVING THE SUPPLEMENTAL INVESTMENT PROGRAM (SIP) NO. 3, CY 2023 OF SUAL, PANGASINAN AMOUNTING TO ONE HUNDRED THIRTY-EIGHT MILLION SIX HUNDRED FIFTY-SEVEN THOUSAND PESOS (PHP138,657,000.00)”

WHEREAS, the Sangguniang Bayan of Sual, Pangasinan submitted its Resolution No. 2023-150 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said Resolution with the following findings:

1. Subject resolution is in consonance to Sections 106, 109 and 114 of the Local Government Code (LGC) of 1991. The Local Development Council of Sual, Pangasinan had identified items in their Supplemental Investment Program (SIP) No. 3 for CY 2022. This was endorsed to the Sangguniang Bayan for approval on July 25, 2023 by the Municipal Development Council thru Resolution No. 5, Series of 2023;
2. The SIP No. 3 covers fund augmentation for Personal Service, Maintenance and Other Operating Expenses, and Capital Outlay of some municipal government offices, and the implementation of disaster risk reduction and management programs and other priority development projects of the LGU; and

3. Funding support for the implementation of the same in the amount of PhP138,657,000.00 is embodied in their proposed Supplemental Budget No. 03 CY 2023 which was enacted by their Sangguniang Bayan thru Appropriation Ordinance No. 04, CY-2023 on August 16, 2023 and approved by the Municipal Mayor on August 25, 2023.

WHEREAS, the Sangguniang Panlalawigan, after final evaluation, finds the subject resolution in order, however, compliance with all the existing laws, rules and regulations shall be the responsibility of the Municipal Government of Sual, Pangasinan;

WHEREFORE, in view of the foregoing, on motion of SP Members Napoleon C. Fontelera, Jr. and Apolonia DG. Bacay and co-sponsored by SP Members Jerome Vic O. Espino, Jeanne Jinky C. Zaplan and Arthur C. Celeste, Jr., duly seconded, it was—

RESOLVED, by the Sangguniang Panlalawigan in session assembled, to approve Resolution No. 2023-150 of the Sangguniang Bayan of Sual, Pangasinan, entitled “Approving the Supplemental Investment Program (SIP) No. 3, CY 2023 of Sual, Pangasinan Amounting to One Hundred Thirty-Eight Million Six Hundred Fifty-Seven Thousand Pesos (Php138,657,000.00)”;
