**PROVINCIAL RESOLUTION NO. 1000-2022**

**AUTHORIZING THE PROVINCIAL GOVERNOR, RAMON V. GUICO III, TO ENTER INTO AND SIGN A DEED OF DONATION AND RECEIVE FIFTEEN (15) AIR CONDITIONING UNITS FROM THE ENERGY REGULATORY COMMISSION FOR THE LINGAYEN DISTRICT HOSPITAL**

**WHEREAS**, the Energy Regulatory Commission is an independent electric power industry regulator that equitably promotes and protects the interests of consumers and other stakeholders to enable the delivery of long-term benefits that contribute to sustained economic growth and an improved quality of life;

**WHEREAS**, the Provincial Government of Pangasinan, through the Lingayen District Hospital, will be the recipient of fifteen (15) air conditioning units from the Energy Regulatory Commission in the form of a donation and hereby expresses its willingness to accept the same;

**WHEREAS**, the air conditioning units will be utilized by the Lingayen District Hospital in order to help enhance its delivery of effective public health care;

**WHEREAS**, it is to the best interest of the Provincial Government of Pangasinan to sign the Deed of Donation and accept the equipment from the Energy Regulatory Commission to further augment the need for the implementation of health programs and services to the people of Pangasinan;

**WHEREAS**, this measure granting authority to the Honorable Governor to enter into and sign a Deed of Donation with the Energy Regulatory Commission is anchored on Sections 22 (a) (5) (c), and 465 (vi) of the Local Government Code of 1991;

**WHEREAS**, for the above purpose, a Deed of Donation shall be entered into and signed between the Province of Pangasinan, represented by Governor Ramon V. Guico III, and the Energy Regulatory Commission, represented by its Chairperson and Chief Executive Officer, Ms. Monalisa C. Dimalanta;



**NOW, THEREFORE**, on motion of SP Member Shiela Marie F. Baniqued, duly seconded, it was –


