**APPROVING RESOLUTION NO. 148-2022 OF THE SANGGUNANG BAYAN OF AGNO, PANGASINAN, ENTITLED "APPROVING SUPPLEMENTAL NO. 6 OF THE ANNUAL INVESTMENT PROGRAM, CALENDAR YEAR 2022 OF THE MUNICIPALITY OF AGNO, PANGASINAN"**

**WHEREAS**, the Sangguniang Bayan of Agno, Pangasinan submitted its SB Resolution No. 148-2022 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

**WHEREAS**, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said SB Resolution with the following findings:

1. Subject resolution is in consonance to Sections 106, 109 and 114 of the Local Government Code (LGC) of 1991. The Local Development Council of Agno, Pangasinan has identified items in their Supplemental Investment Program (SIP) No. 6 for CY 2022. This was endorsed to the Sangguniang Bayan for approval on November 9, 2022 by the Municipal Development Council Executive Committee thru Resolution No. 07-2022;
2. Said SIP No. 6 of the municipality covers fund augmentation for Personal Services and Maintenance and Other Operating Expenses of some municipal government offices of LGU Agno;

Funding support for the implementation of the same in the amount of Php1,319,416.80 is embodied in their proposed Supplemental Budget No. 5, Calendar Year 2022, which was enacted by the Sangguniang Bayan thru Appropriation Ordinance No. 2022-06 on November 14, 2022 and approved by the Municipal Mayor on November 15, 2022;




