### RESOLUTION NO. 1006-2022

**APPROVING RESOLUTION NO. 139, S-2022 OF THE SANGGUNANG BAYAN OF INFANTA, PANGASINAN, ENTITLED "APPROVING THE SECOND SUPPLEMENTAL ANNUAL INVESTMENT PROGRAM (AIP) FOR CALENDAR YEAR 2022 OF THE MUNICIPALITY OF INFANTA, PANGASINAN"**

**WHEREAS**, the Sangguniang Bayan of Infanta, Pangasinan submitted its SB Resolution No. 139, S-2022 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No.7160, otherwise known as the Local Government Code of 1991;

**WHEREAS**, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said SB Resolution with the following findings:

1. Subject resolution is in consonance to Sections 106, 109 and 114 of the Local Government Code (LGC) of 1991. The Local Development Council of Infanta, Pangasinan has identified items in their First Supplemental Annual Investment Program (SAIP) for CY 2022. This was endorsed to the Sangguniang Bayan on September 29, 2022 through MDC Resolution No.2 S-2022 and was favorably acted upon by the Sangguniang Bayan on October 25, 2022;
2. The SAIP No. 2 of the municipality covers fund augmentation for Personal Services, Maintenance and Other Operating Expenses, and Capital Outlay of some municipal government offices;

3. Funding support for the proposed SAIP, with a total investment requirement of PhP2,876,453.33, is embodied in the municipality's Supplemental Budget No. 2 CY 2022, which was approved and enacted by their Sangguniang Bayan through Appropriation Ordinance No.02, Series of 2022 on October 25, 2022; and
4. However, the proposed programs/projects to be funded under the unexpended LDRRM Fund FY 2021 amounting to PhP1,166,202.27 shall be incorporated in the revised Annual Investment Program pursuant to Section 6.5 of the NDRRMC-DBM-DILG Joint Memorandum Circular No. 2013-1 dated March 25, 2013, which states: "The unexpended balances of the LDRRMF may be released and utilized for new expenditure items upon submission of a revised AIP as approved by the local sanggunian and Local Chief Executive (LCE) upon recommendation of the LDRRMC in accordance with the approved LDRRMP".

**WHEREAS**, the Sangguniang Panlalawigan, after final evaluation, finds the subject resolution in order, however, compliance with all the existing laws, rules and regulations shall be the responsibility of the Municipal Government of Infanta, Pangasinan;

**WHEREFORE**, in view of the foregoing, on motion of SP Members Napoleon C. Fontelera, Jr. and Apolonia DG. Bacay and co-sponsored by SP Members Jerome Vic O. Espino, Jeanne Jinky C. Zaplan and Arthur C. Celeste, Jr., duly seconded, it was—

**RESOLVED**, by the Sangguniang Panlalawigan in session assembled, to approve Resolution No. 139, S-2022 of the Sangguniang Bayan of Infanta, Pangasinan, entitled "Approving the Second Supplemental Annual Investment Program (AIP) for Calendar Year 2022 of the Municipality of Infanta, Pangasinan";
