RESOLUTION NO. 1008-2022

DECLARING ORDINANCE NO. 186, S-2022 OF THE SANGGUNIANG BAYAN OF BASISTA, PANGASINAN, ENTITLED "AN ORDINANCE REQUIRING FISHPOND OWNERS TO INSTALL APPROVED WARNING DEVICES AT LEAST TWO (2) METERS AROUND THEIR FISHPONDS OR ANY DEEP EXCAVATION AND THE LIKE AND IMPOSING PENALTIES THEREOF" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIANG TO ENACT

WHEREAS, the Sangguniang Bayan of Basista, Pangasinan submitted its Ordinance No. 186, S-2022 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Legal Officer of the Province have conducted initial review and study on said municipal ordinance and found out that the same was enacted in accordance with Section 447 (a) (5) (viii) of R.A. No. 7160 and Section 5 of Article II of the 1987 Philippine Constitution;

WHEREAS, subject ordinance shall take effect after the Sangguniang Bayan has complied with the requirement of publication pursuant to Section 511 (a) of RA 7160;

WHEREFORE, in view of the foregoing, on motion of SP Members Philip Theodore E. Cruz and Haidee S. Pacheco and co-sponsored by SP Members Jerome Vic O. Espino, Jeanne Jinky C. Zaplan and Arthur C. Celeste, Jr., duly seconded, it was –




