DECLARING ORDINANCE NO. 186, S-2022 OF THE SANGGUNIANG BAYAN OF BASISTA, PANGASINAN, ENTITLED "AN ORDINANCE REQUIRING FISHPOND OWNERS TO INSTALL APPROVED WARNING DEVICES AT LEAST TWO (2) METERS AROUND THEIR FISHPONDS OR ANY DEEP EXCAVATION AND THE LIKE AND IMPOSING PENALTIES THEREOF" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIAN TO ENACT
