RESOLUTION NO. 1009-2022

DECLARING MUNICIPAL ORDINANCE NO. 1-2022 OF THE SANGGUNIANG BAYAN OF URBIZTONDO, PANGASINAN, ENTITLED "AN ORDINANCE ENACTING THE ENVIRONMENT CODE OF 2022 OF THE MUNICIPALITY OF URBIZTONDO, PANGASINAN" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIAN TO ENACT

WHEREAS, the Sangguniang Bayan of Urbiztondo, Pangasinan submitted its Ordinance No. 1, S-2022 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Legal Officer of the Province have conducted initial review and study on said municipal ordinance and found out that the same was enacted in accordance with R.A. No. 8749 or Clean Air Act of 1999, R.A. No. 9003 or Solid Waste Management Act, R.A. No. 9275 or Clean Water Act, the General Welfare Clause under Sections 16, 17 (a) (2) (vi) and 447 (1) (iii) (vi) of R.A. No. 7160;

WHEREAS, subject ordinance shall take effect after the Sangguniang Bayan has complied with the requirements of posting and publication pursuant to Sections 59 (c) and 511 (a) of RA 7160;

WHEREFORE, in view of the foregoing, on motion of SP Members Philip Theodore E. Cruz and Haidee S. Pacheco and co-sponsored by SP Members Jerome Vic O. Espino, Jeanne Jinky C. Zaplan and Arthur C. Celeste, Jr., duly seconded, it was—


