APPROVING IN PART RESOLUTION NO. 2022-084 OF THE SANGGUNANG BAYAN OF STA. BARBARA, PANGASINAN, ENTITLED “APPROVING THE SUPPLEMENTAL INVESTMENT PROGRAM NO. 2022-02 OF THE MUNICIPAL GOVERNMENT OF STA. BARBARA, PANGASINAN CALENDAR YEAR 2022, REQUIRING A TOTAL FUNDING OF SIX MILLION SEVENTEEN THOUSAND EIGHT HUNDRED THIRTY ONE PESOS (P6,017,831.00)”

WHEREAS, the Sangguniang Bayan of Sta. Barbara, Pangasinan submitted its SB Resolution No. 2022-084 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said SB Resolution with the following findings:

1. The Municipal Development Council of Sta. Barbara, Pangasinan prepared the LGU's Supplemental Investment Program (SIP) No. 2022-02, CY 2022. This was endorsed by the Council, through MDC Resolution No. 2022-11, Series of 2022 dated October 13, 2022, to the Sangguniang Bayan for approval;

2. Said Supplemental AIP, which has a total investment requirement of ₱6,017,831.00, covers augmentation of funds for Personal Services (PS), Maintenance and Other Operating Expenses (MOOE) and Capital Outlay (CO) of some offices of the LGU, and implementation of priority projects of the Municipal Government; and
3. Funding for the Supplemental AIP will be sourced from the savings of the LGU is embodied in the LGU's Supplemental Budget No. 2022-02, FY 2022 which was enacted by their Sangguniang Bayan through Appropriation Ordinance No. 2022-008, Series of 2022 dated October 24, 2022.

WHEREAS, however, the appropriation for SSS Premiums to regular employees is not allowed since premium only applies to Self-employed Contractual and Job Order Personnel not covered by GSIS Law, pursuant to DILG Memorandum Circular No. 2014-83 dated July 18, 2014;

WHEREAS, the Sangguniang Panlalawigan, after final evaluation, finds the subject resolution in order, however, compliance with all the existing laws, rules and regulations shall be the responsibility of the Municipal Government of Sta. Barbara, Pangasinan;

WHEREFORE, in view of the foregoing, on motion of SP Members Shiela Marie F. Baniqued and Vici M. Ventanilla and co-sponsored by SP Members Jerome Vic O. Espino, Jeanne Jinky C. Zaplan and Arthur C. Celeste, Jr., duly seconded, it was—

RESOLVED, by the Sangguniang Panlalawigan in session assembled, to approve Resolution No. 2022-084 of the Sangguniang Bayan of Sta. Barbara, Pangasinan, entitled “Approving the Supplemental Investment Program No. 2022-02 of the Municipal Government of Sta. Barbara, Pangasinan Calendar Year 2022, requiring a total funding of Six Million Seventeen Thousand Eight Hundred Thirty One Pesos (P6,017,831.00)”;

RESOLVED FURTHER, that a copy of this resolution be furnished the Office of the Sangguniang Bayan of Sta. Barbara, Pangasinan, for its information and guidance.
