RESOLUTION NO. 1013-2022

DECLARING MUNICIPAL ORDINANCE NO. 2022-016 OF THE SANGGUNIANG BAYAN OF TAYUG, PANGASINAN, ENTITLED "AN ORDINANCE AUTHORIZING THE TEMPORARY CLOSURE OF ONE LANE OF MAGSAYSAY STREET FROM CORNER ZARAGOZA STREET TO CORNER RIZAL STREET AND DECLARING THE OTHER LANE AS A ONE WAY TRAFFIC TO COMMENCE EVERY DECEMBER 1 UNTIL JANUARY 6 FOR THE ANNUAL CELEBRATION OF CHRISTMAS AND NEW YEAR AND EVERY FEBRUARY 20 UNTIL MARCH 25 DURING TOWN FIESTA CELEBRATION IN TAYUG, PANGASINAN" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIAN TO ENACT

WHEREAS, the Sangguniang Bayan of Tayug, Pangasinan submitted its Ordinance No. 2022-016 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Legal Officer of the Province have conducted initial review and study on said municipal ordinance and found out that the same was enacted in accordance with Section 21 (a) (c) of R.A. No. 7160 and Article 43 of its Implementing Rules and Regulations;




