APPROVING RESOLUTION NO. 2022-168 OF THE SANGGUNIANG PANLUNGSOD OF ALAMINOS CITY, PANGASINAN, ENTITLED “CONFIRMING/APPROVING IN TOTO THE PROPOSED CY 2022 SUPPLEMENTAL ANNUAL INVESTMENT PROGRAM NO. 02 OF THE CITY OF ALAMINOS, PANGASINAN AMOUNTING TO FIFTY-SEVEN MILLION SEVEN HUNDRED NINE THOUSAND FOUR HUNDRED FIFTY FOUR PESOS AND THIRTY CENTAVOS (PHP57,709,454.30)”

WHEREAS, the Sangguniang Panlungsod of Alaminos, Pangasinan submitted its SP Resolution No. 2022-168 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No.7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said SB Resolution with the following findings:

1. Subject resolution is in consonance to Sections 106, 109 and 114 of the Local Government Code (LGC) of 1991. The Local Development Council of Alaminos City, Pangasinan had identified items in their Supplemental Annual Investment Program (SAIP) No. 02, Series of 2022. This was endorsed to the Sangguniang Panlungsod for approval on September 27, 2022 by the City Development Council thru Resolution No.2022-02 Series of 2022, and was favorably acted upon by the Sangguniang Panlungsod on October 04, 2022;

2. Said SIP covers fund augmentation for Personal Services, Maintenance and Other Operating Expenses and Capital Outlay of some city government offices, and the implementation of disaster risk reduction management programs/projects of the LGU; and
3. Funding support for the implementation of the same in the amount of PhP57,709,454.30 is embodied in their proposed Supplemental Budget No. 2 for Fiscal Year 2022 which was enacted by their Sangguniang Panlungsod thru Appropriation Ordinance No. 2022-02 on October 11, 2022 and approved by the Mayor on October 25, 2022.




