**APPROVING RESOLUTION NO. 2022-104 OF THE
SANGGUNIAN BAYAN OF BOLINAO, PANGASINAN,
ENTITLED "ADOPTING THE REVISED ANNUAL
INVESTMENT PROGRAM CY 2022 OF THE MUNICIPALITY OF
BOLINAO, PANGASINAN"**

WHEREAS, the Sangguniang Bayan of Bolinao, Pangasinan submitted its SP Resolution No. 2022-104 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No.7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said SB Resolution with the following findings:

1. Subject resolution revises the previously approved Annual Investment Program CY 2022 of the LGU;
2. Said revision emanated from the Municipal Disaster Risk Reduction and Management Council which was endorsed to the Local Development Council on September 17, 2022 thru MDRRMC Res. No. 04, Series of 2022, realigning the PhP9,044,649.17 from the 5% MDRRM Fund unexpended balances from LDRRMF CYs 2014 to 2021 and from the reprogrammed LDRRMF CY 2022 to finance the procurement of one (1) unit backhoe for disaster search and rescue operations;

3. The Local Development Council endorsed the same to the Sangguniang Bayan for approval on September 30, 2022 thru MDC Res. No. 5, Series of 2022. This is in accordance to item 6.5 of the NDRRMC-DBM-DILG JMC No. 2013-1 dated March 25, 2013, NDRRMC-DBM-DILG JMC No. 2013-1 (The unexpended balances of the LDRRMF may be released and utilized for new expenditure items upon submission of a revised AIP as approved by the local Sanggunian and Local Chief Executive (LCE) upon recommendation of the LDRRMC in accordance with the approved LDRRMP).


WHEREAS, the Sangguniang Panlalawigan, after final evaluation, finds the subject resolution in order, however, compliance with all the existing laws, rules and regulations shall be the responsibility of the Municipal Government of Bolinao, Pangasinan;

WHEREFORE, in view of the foregoing, on motion of SP Members Napoleon C. Fontelera, Jr. and Apolonia DG. Bacay and co-sponsored by SP Members Jerome Vic O. Espino, Jeanne Jinky C. Zaplan and Arthur C. Celeste, Jr., duly seconded, it was—
