**RESOLUTION NO. 1017-2022**

**DECLARING MUNICIPAL ORDINANCE NO. 076-2022 OF THE SANGGUNANG BAYAN OF LABRADOR, PANGASINAN, ENTITLED "AN ORDINANCE DECLARING FIRST FRIDAY OF AUGUST OF EVERY CALENDAR YEAR AS ARBOR DAY IN THE MUNICIPALITY OF LABRADOR, PANGASINAN" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIAN TO ENACT**

**WHEREAS**, the Sangguniang Bayan of Labrador, Pangasinan submitted its Ordinance No. 076-2022 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

**WHEREAS**, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Legal Officer of the Province have conducted initial review and study on said municipal ordinance and found out that the same was enacted in accordance with General Welfare Clause under Section 16 and Section 447 (a) (1) (vi), (4) (i), and (5) (i) of R.A. No. 7160 and Republic Act No. 10176 "An Act Reviving the Observance of Arbor Day by Authorizing the Local Government Units the Responsibilities for Celebrating the Day for Tree Planting as an Annual Event;

**WHEREAS**, subject ordinance shall take effect after the Sangguniang Bayan has complied with the requirement of posting pursuant to Sections 59 (c) of RA 7160;

**WHEREFORE**, in view of the foregoing, on motion of SP Members Philip Theodore E. Cruz and Haidee S. Pacheco and co-sponsored by SP Members Jerome Vic O. Espino, Jeanne Jinky C. Zaplan and Arthur C. Celeste, Jr., duly seconded, it was—




