**APPROVING RESOLUTION NO. 2022-225 OF THE SANGGUNANG BAYAN OF SISON, PANGASINAN, ENTITLED "APPROVING THE ANNUAL INVESTMENT PROGRAM FOR CY 2023 OF THE MUNICIPALITY OF SISON, PROVINCE OF PANGASINAN"**

**WHEREAS**, the Sangguniang Bayan of Sison, Pangasinan submitted its SB Resolution No. 2022-225 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No.7160, otherwise known as the Local Government Code of 1991;

**WHEREAS**, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said SB Resolution with the following findings:

1. The Municipal Development Council of Sison, Pangasinan has formulated the municipality's Annual Investment Program for Calendar Year 2023, which was endorsed to the Sangguniang Bayan for approval through MDC Resolution No.02-2022 Series of 2022 dated June 30, 2022. This is in pursuance to Sections 106, 109, and 114 of the Local Government Code of 1991;
2. The AIP of the municipality is in accordance with the Budget Operations Manual (BOM) for LGUs, 2016 Edition and in pursuance to DILG-NEDA-DBM-DOF Joint Memorandum Circular No. 1 series of 2007 dated March 8, 2007 DBM-CCC-DILG JMC No. 2014-01 dated August 7, 2014, as amended by DBM-CCC-DILG JMC No.2015-

01 dated July 23, 2015 as to format and content. The AIP of Sison, Pangasinan was formulated following the prescribed AIP Summary Form categorized into general public, social, economic, and other services. It likewise covers: (a) all the regular budgetary items for the operations of the different city offices broken down into PS, MOOE, and Capital Outlay; (b) the priority development programs/projects and those to be funded by the 20% development fund, and; (c) disaster risk reduction management programs/projects/activities of the city. It further includes the following: 1) Gender and Development Plan, Peace and Order Plan (to include PPAs to address problems on illegal drugs), Local Nutrition Action Plan, Annual Cultural Development Plan, Climate Change Action Plan, Local Youth Development Plan, Annual Procurement Plan, and; 2) list of programs/projects/activities for the Local Council for Protection of Children, Senior Citizens and Persons with Disabilities, PPAs to combat Acquired Immune Deficiency Syndrome;

3. The AIP has a total investment requirement amounting to Php 229,501,393.00 which will be funded from the municipality's proposed 2023 Annual Budget, enacted on October 17, 22 through Appropriation Ordinance No.02, Series of 2022 and was approved by the Municipal Mayor on October 21, 2022;
4. The development fund amounting to Php 35,837,879.00, which is allocated for development projects is equivalent to the 20% of the municipality's IRA amounting to Php179,189,393.00 for CY 2023. This is in accordance with Section 287 of RA 7160;
5. The identified development programs/projects to be funded by the 20% of IRA are based on the DILG-DOF-DBM Joint Memorandum Circular No. 1 dated November 4, 2020 (Revised Guidelines on the Appropriation and Utilization of the 20% of the Annual Internal Revenue Allotment for Development Projects)The identified programs/projects/activities to be funded by the 5% Local Disaster Risk Reduction and Management Fund of the municipality amounting to Php 11,404,320.00 conforms with Section 21 of RA 10121 and NDRRMC-DBM and DILG Memo Circular No. 2013-1 dated March 25, 2013 (Allocation and Utilization of Local Disaster Risk Reduction and Management Fund). Also, the LDRRMFI Plan 2023 of the municipality was endorsed by the MDRRMC to the SB on June 30, 2022 thru MDRRMC Res. No. 02-2022. Further, the plan has been reviewed by the Office of Civil Defense (OCD) as per attached OCD Certification dated September 13, 2022;

6. The LGU has also identified programs/projects/activities responsive to climate change and tagged its corresponding expenditures in their AIP. This is in pursuance to DBM-CCC-DILG Joint Memorandum Circular No. 2015-01 dated July 23, 2015; and
7. The Gender and Development Plan of the municipality has been reviewed by the Department of the Interior and Local Government (DILG) and was found to be fully compliant in form and contents with the provisions of the Joint Memo Circular of 2016-01: Amendments to JMC 2013-01 re: Guidelines on Localization of the Magna Carta of Women as per attached Certificate of Review and Endorsement of the DILG dated June 9, 2022.




